City of Lake Park Emergency Call Meeting Minutes

August 10, 2017 6:30 PM

Mayor Schindler called the Emergency Call Meeting to order and led the Pledge of Allegiance.

Those present were as follows; Mayor Schindler, Mayor Pro Tem Debbie Sauls, Council Members Ronald Carter, Rubinell McDonald, and Jena Sandlin, Clerk Tabatha Fowler, Clerk Consultant Ann Peterson, Police Chief Breletic, Maintenance Supervisor Jeff Patterson and citizens.

Mayor and Council began by going through proposed department budgets looking for ways to cut cost and decrease expenses.

While covering the Fire Department budget, Mayor explained to Council what the effects would be to change the fire department volunteers from a 1099 tax form to a W2 tax form, per city auditor. After discussion, Member Carter made a motion/recommendation to change the fire department to W2 tax forms, Member Sauls second for discussion. When question called, Member Carter in favor, Member Sauls, Sandlin, and McDonald oppose. Motion failed.

Mayor and Council continued with proposed budget review to determine the future expenses and revenues projected for 2018.

Mayor asked for Council to discuss the 2017 Tax Millage rate. After much discussion, Member Carter made a motion to tentatively adopt and advertise a 2017 millage rate increase of 1 mill from 6.552 to 7.552 for the 2017 millage rate, Member Sauls second, all in favor motion passed.

Mayor asked for Council to set dates for the three Public Hearings that are required for a millage increase, and a date for the Call Meeting for the Council to vote on the millage rate. Those dates were set as follows;

- 1. Public Hearing Thursday August 17, 2017 at 8:30 AM
- 2. Public Hearing Thursday August 17, 2017 at 7:30 PM
- 3. Public Hearing Tuesday August 22, 2017 at 7:30 PM

Call Meeting Date set for Tuesday August 29, 2017 at 7:30 PM.
