The City of Lake Park will be holding a work session on Monday June 26, 2018 at 12:00 PM at the Lake Park City Hall.

Council reviewed the Department reports submitted for review. No action taken.

Mayor advised Council to begin preparing for 2019 Budget discussion. No action taken.

Mayor and Council reviewed the temporary salaries & Clerk's Education and Training expenses for the month of May. Council asked if court training recertification hotel expense could be lowered if room was reserved at a different hotel than the conference takes place. Clerk said she would research and get back to Council at Regular Meeting. Mayor and Council also discussed a possible job description and stipend for Emergency Management Liaison. Clerk is to contact Ashley Tye regarding a job description. No action taken.

Lake Park Christmas Jubilee discussion – Julie Wilbers advised that she had introduced herself to the ladies at Southern Occasions and that they discussed several ideas and Wilbers was able to give them more details on previous events. Mayor also made some announcements regarding the July 4th Celebration. No action taken.

Mayor and Council reviewed and read aloud the revised Tom's Pond Ordinance 119. After making some additional changes to the wording, Council set the first reading to be held on Tuesday July 3, 2018. No action taken.

James Council Jr., Tom's Pond Road, Lake Park, requested to speak to Mayor and Council concerning section (c) #3 of the ordinance. He also thanked the Council for their reconsideration of the Ordinance.

Clerk asked to move the item of Utility Line Locator to the next work session agenda. Council asked for clerk to contact SGRC to inquire about them doing corrections or completion to the GIS surveying of the utility system.
