## City of Lake Park Call Meeting Minutes April 9, 2019 6:00 PM

Mayor Keith Sandlin welcomed everyone and called the meeting to order.

Those present for the meeting were as follows; Mayor Sandlin, Mayor Pro Tem Ronald Carter, Council Members Tom Barr, Tyler Davis, and Carl Taylor. Also present were Attorney Plumb, Clerk Tabatha Fowler, Police Chief Kinsey, and Maintenance Supervisor Jeff Patterson.

Member Carter began by making a motion to add the backhoe as an agenda item for discussion, Member Barr second, all in favor motion passed.

Mayor called Chief Kinsey to come forward with his recommendations. Kinsey stated that with careful consideration he would like to recommend the hiring of Eugene Benefield. He went on to say that he is currently employed by the City of Lakeland and would be available after working a two week notice. Kinsey also said that Benefield had a lot of positive references and a great work history. After some discussion, Member Barr made a motion to authorize Chief Kinsey to hire Eugene Benefield as a full time officer, Member Taylor second, all in favor motion passed.

Member Barr asked if he could ask Chief Kinsey a question about the street near the apartments, Mayor approved. Discussion about Casamonica being released to the city from Tishco followed. No action taken.

Clerk asked if Council was going to vote on part time officers, Mayor advised they would do that at the next meeting.

Mayor Sandlin called for discussion of drainage issue on Broadway. Member Davis stated that he had called the property owner to discuss allowing the city to go onto property to bust up beaver dams that have caused a serious drainage issue. Davis said that it was a no go and that he would defer back to the Council and Attorney. Council and Attorney discussed options on course of action to take. No action taken.

Mayor called for discussion of the backhoe. Council discussed the pros and cons of the purchase of a 2005 Case Backhoe that was offered to the city. Clerk advised that feelers had been put out for financing possibilities. No action taken.

Mayor Sandlin stated that they would have to go into Executive Session to discuss Litigation. Member Taylor made a motion to go into Executive Session to discuss pending litigation, Member Barr second, all in favor, motion passed.

Executive session began at 6:35 PM. Member Davis made a motion to close out of Executive Session at 7:10 PM and authorize the Mayor to sign the affidavit and resolution of executive session, Member Barr second, all in favor.

Executive session ended at 7:10 PM.

Clerk asked for confirmation on the April Work Session to be held on Monday April 29 at 6:00 PM. All agreed.

Being no further business, Member Taylor made a motion to adjourn, Member Carter second, all in favor, meeting adjourned at 7:12 PM.
