Mayor Keith Sandlin called the work session to order. Those present were as follows; Mayor Pro Tem Ronald Carter, Council Members Tom Barr, Tyler Davis, and Carl Taylor. Also present were Clerk Tabatha Fowler and Fire Chief Brown.

Mayor called for review of department reports

Fire Department – Chief David Brown came forward to give the department report. (see attached) He further reviewed the details of the Rescue 1 truck that is currently inoperable. No action taken.

Police – No report

Maintenance Department-No report

Mayor Sandlin called for update on Broadway issues. Member Davis stated that he has been unsuccessful finding an appraiser to take on the job. He further stated that the clerks have now been asked to expand the search and will update again at a later time. No action taken.
