City of Lake Park Regular Meeting Minutes October 1, 2019 6:00 PM

Mayor Keith Sandlin welcomed everyone then led the Pledge of Allegiance followed by an invocation given by Mayor Pro Tem Ronald Carter.

Those present for the meeting were as follows; Mayor Sandlin, Mayor Pro Tem Ronald Carter, Council Members Tom Barr, and Tyler Davis and Carl Taylor. Also present were Clerks Tabatha Fowler and Connie Martinez, Fire Chief David Brown, and Maintenance Supervisor Jeff Patterson.

Mayor Sandlin called for review of the minutes from September 3 Regular Meeting, September 5 Emergency Call Meeting, and September 23 Work Session. Member Carter made a motion to accept minutes as presented, Member Davis second, all in favor motion passed.

Mayor called for review of the September financials. Member Carter made a motion to accept the financials as presented, Member Davis second, all in favor motion passed.

Mayor Sandlin called for Citizens' Concerns

June Yeomans, 900 Broadway, came forward to address Council. She asked to know when the city was going to do something about the Schindler mobile home. She stated that the Judge had ruled and she wanted to know when the city was going to make him move it.

Julie Wilbers, 360 Back Forty, came forward to address Council. Mrs. Wilbers submitted a printed copy of her statement and questions regarding the revisions to Ordinance 114. (see attached)

Mayor called for department reports.

Police Department – report submitted during previous work session. Council called on Sgt. Langley and asked about the department qualifying and he confirmed that they would all complete qualifying by the end of October.

Fire Department – Chief David Brown came forward to give his report. (see attached)

Maintenance Department-Jeff Patterson came forward to give his report. He reported on issues with the mower and bucket truck, confirmed the window replacement in the backhoe, and the seat reupholstered in the maintenance truck.

Mayor Sandlin called for review of the Parks and Recreation Committee/Ordinance 114 Amendment. Member Carter stated that with the concern expressed about the Ordinance that Council should review it further. No action taken at this time.

Parks and Recreation Committee Appointment & Committee Update- No action taken at this time.

Mayor called for review of the engineer agenda item. Clerk Fowler read aloud the engineer report submitted by Arrow Engineering on Casamonica Drive. (see attached) Member Davis made a motion to submit findings from the engineer report to Tishco, Member Taylor second, all in favor motion passed. Member Taylor made a motion to designate Arrow Engineering as the city's engineer on record, Member Barr second, all in favor motion passed.

Mayor Sandlin called for review of the drainage issues and asked for a motion on Jackson Circle. Member Davis made a motion to send a letter to both property owners stating that the city is closing the drainage discussion due to lack of lack of property owners cooperation, Member Barr second and motion passed. Member Taylor addressed the drainage on Broadway. He stated that Council needed to make a decision as to how to proceed now since the property owner has refused to allow further access even with the transfer of county easement. We need to find out if the easement is valid and how we should proceed. Member Taylor then made a motion to have the attorney to proceed with obtaining access to the property through legal action, Member Davis second all in favor the motion passed.
