Mayor Pro Tem Ronald Carter welcomed everyone to the meeting.

Those present for the meeting were as follows; Mayor Pro Tem Ronald Carter, Council Members Tom Barr, and Tyler Davis and Carl Taylor. Also present were Clerk Tabatha Fowler, Police Chief David Kinsey, and Judge Carlos Rodgers.

Mayor Pro Tem Carter explained the reason for the meeting was due to miscommunication regarding the court judge position which led to a possible unlawful motion and vote. This meeting is to correct that and allow Judge Rodgers the opportunity to speak on his behalf.

Judge Rodgers asked for Council to go into Executive Session to discuss personnel. Member Barr made a motion to go into Executive Session to discuss personnel, Member Davis second, all in favor motion passed. Council adjourned into Executive Session at 6:04 PM.

Member Taylor made a motion to come out of Executive Session, authorize Mayor Pro Tem Carter to sign the Executive Session affidavit and resolution, and continue regular session at 7:00 PM. Member Davis second, all in favor motion passed.

Mayor Pro Tem Carter again addressed the reason for the meeting was to correct an error in the previous meeting held on Tuesday September 3, 2019. He went on to recommend a reversal of the motion made to change judges during that meeting since it was done in error.

Member Taylor made a motion to rescind the prior motion from September 3, 2019 to change judges, Member Davis second, all in favor motion passed.

Being no further agenda items, Mr. Carter called for a motion to adjourn. Member Taylor made a motion to adjourn, Member Barr second, all in favor, motion passed and meeting adjourned at 7:05 PM.
