City of Lake Park Emergency Call Meeting Minutes
March 17, 2021
11:00 AM

Mayor Keith Sandlin called the Emergency Call Meeting to order. Those present were as follows; Mayor Sandlin, Mayor Pro Tem Ronald Carter, Council Members Tom Barr, Carl Taylor, and June Yeomans. Also present were Fire Chief David Brown, and Clerk Tabatha Fowler.

Mayor Sandlin stated that the meeting was called to discuss the bids submitted for the water project on Essa Street.

Clerk Fowler stated that Arrow Engineering wasn't able to attend but emailed that they recommended going with the bid from Killeen Construction. The collected and submitted by Arrow Engineering were as follows; SCI, Standard Contractors, Inc. for \$31,333, and Killeen Construction for \$26,639.64.

Member Taylor stated he was concerned about the previous discussion regarding the 2" line to suffice that area and he is more support of the 6" line. Another concern is that we are making an effort and special exception for someone that the city is actually in litigation with right now and has cost the city several thousands of dollars, and he doesn't see why the city should make a special exception for him. If it was "Joe Smith" Construction, they would have to wait for a Work Session and Regular Meeting to have this business discussed. Taylor said he wanted it on record that he was opposed to have it even brought up for a vote today.

Member Yeomans stated she had talked to him earlier and that he doesn't have any water and that he paid his deposit months ago and they need to get him water.

Mayor Sandlin asked if someone would make a motion on one of the contractors.

Member Yeomans made a motion to accept the bid from Killeen Construction for \$26,639.64. Mayor called for a second, there was none. Mayor asked Member Carter if he was not in favor of it. Member Carter stated he had concerns about the size line to use to provide water. Member Yeomans says if they are going to furnish water to the citizens of Lake Park then they need to furnish him water.

Mayor stated they had a motion on the table, three opposed and one in favor.

Mayor explained that this was not an emergency meeting that the clerk put that on there and that this was a special meeting, he further stated that according to the city charter the Mayor or any 2 Council Members could call a special meeting. This was a special meeting not an emergency meeting to call favor on somebody.

The motion died. Member Taylor made a motion to adjourn, Member Carter second, all in favor motion passed.
